Here, the valid version of the Berlin Grünanlagengesetz applies. Further liability on the part of Grün Berlin GmbH as operator of Britzer Garden is excluded. Visiting Britzer Garden takes place at your own risk. There is no obligation to provide illumination or to clear packed snow or ice. There is no claim concerning the availability of facilities and infrastructure in the park. You are liable for any damage you cause.

## Our opening times:

Our opening times vary depending on the time of year. You can find our current times at the park entrances and on our website.

There may be special arrangements in place for special events.

## Admission regulations:

To visit the park, you require an **annual or day pass**. More detailed information on **pricing and reductions** can be found on our website [britzergarten.de](http://britzergarten.de).

Your entry pass is not just important for getting in; you will need it throughout your visit. Park supervisors may check your ticket for its **validity**. To ensure fairness for everyone, we will require you to pay **three times the price of a day pass** should you be unable to produce your ticket. Our annual passes are only issued on an individual basis. This means that it is only valid for you

Your **vehicle, bike or moped** must remain outside.

**Dogs** and other animals are also not permitted.

Should you require a **guide dog or assistance dog**, you may of course bring this along with you. Please do not forget your official certificate.

## Accessibility:

You will find detailed information on the **condition of the paths** and the topography of Britzer Garden on our website.

For safety reasons, we cannot approve all paths for wheeled access.

Should you require a **tricycle** or an **electric scooter** in order to move around the park, you will need an entry 'G' or 'aG' in your disabled-person's pass. Special permission may be granted in exceptional circumstances. For **special permission** to be granted, please send an email including your name/address and supporting evidence to: [info@britzergarten.de](mailto:info@britzergarten.de), or complete an application form directly at the ticket office.

Depending on availability, **wheelchairs** may be pre-ordered and borrowed free of charge at the Mohriner Allee entrance.

## Activities in the park:

Ideally, you will explore the park by foot; pedestrians have priority here. You may use **skates, scooters, bicycles** or similar on the paved and asphalt paths – this is permitted on weekdays only from April to September, however. At weekends and on public holidays, the risk of accidents is too great. **Children up to the age of five** may bring their skates, balance bikes, scooters and children's bicycles with them into the park at any time, including at the weekend from April to September. Please ensure that the safety of all park visitors is paramount. Please keep an **appropriate speed and distance** to other guests.

You can also explore the park with our **park railway**. Stopping on the tracks is however forbidden. Please ensure you keep a sufficient distance from the tracks. Boarding/ alighting while moving is not permitted for safety reasons.

Because anything that could catch fire can be dangerous, **open fires, barbecues** (including with gas cartridges) and **shisha smoking** are not permitted.

All other kinds of dangerous objects such as **glass bottles, cutting/thrusting weapons and firearms** are of course forbidden.

You may make yourself at home on the short-mown grass areas at any time. **High meadows** are grassland and serve as a winter food source for our livestock in the park. They also offer space for countless insects to develop and may therefore not be accessed.

The **woods, shrub plantations and flowerbeds**, as well as **shoreline vegetation** alongside the lakes and streams, may also not be accessed.

The erecting of **tents and gazebos** and the use of **hammocks and slacklines** is not permitted.

Our animals all receive species-appropriate food in the correct quantities. **Feeding** is therefore not required and not permitted throughout the park. This also applies to all wildlife in the park.

In the model harbour area, you may sail your **model boat without combustion engine** – but please watch out for waterbirds. Speedboats are not authorised. **Model aeroplanes and drones** must also remain outside.

Here, there are lively **water play areas** for cooling off and **Kneipp water points**. Bathing in the lakes, streams and Kneipp points is not permitted. This also applies in winter to accessing the ice areas.

In order to **trade and conduct business** in the park, you require the permission of Grün Berlin GmbH. This also applies to **commercial photo and video shoots**. Unregistered events or meetings are not permitted.

We wish to inform you that by entering the Britzer Garden grounds, you consent to photos being taken and film and TV footage being recorded during your visit – especially during events – for **documentary purposes, for general publicity purposes and for the press, radio and other forms of media** without the right to assert any claims in this regard.

Throw your **rubbish**, papers and cigarette butts into one of the litter bins provided. This helps us to keep Britzer Garden as clean as possible.

Our **park supervisors** at Britzer Garden are there for your safety and have your best interests at heart. They have establishment authority and decide in the event of doubt. Please immediately follow their instructions as contraventions may be prosecuted.
